

Midwest American Bulldog Rescue
FOSTER CONTRACT

I, _____ hereinafter referred to as "Foster Family", on this _____ day of _____, 20____, enter into this Foster Contract and acknowledge receipt from Midwest American Bulldog Rescue, Inc., hereinafter referred to as MWABR, one or more foster dogs into my home. Throughout the adoption processes, the dog in my home may change from time to time, with the understanding that this contract will be provided for, with the best of my ability, in following the terms and conditions below. I understand that this Foster Contract can be amended as needed for the best consideration of the dog.

Terms and Conditions

In addition, the Foster Family agrees to the following terms and provisions:

1. The Foster Family agrees to provide this dog with a safe home, proper care and attention, and humane treatment in accordance with all current and future state, county, and local laws and ordinances where the Foster Family resides. The dog is not to ride loose in the back of trucks, is not to be chained or tied-out, and the Foster Family warrants that the dog will not be contained solely by a hidden fence. The dog is not to be solely an outside pet, and the Foster Family agrees that when the dog is outdoors it shall be protected from the elements, and provided with adequate food, water, fencing.
2. The Foster Family agrees to take the dog to an approved MWABR licensed veterinarian to provide the dog with necessary veterinary care upon emergency sickness, disease, and injury. A list of vets and emergency clinics will be given to the Foster Family.
3. The Foster Family understands that there are costs involved in maintaining a dog, and agrees to assume full responsibility for food, water, and basic health issues including administering the monthly heart worm preventative and flea treatments.
4. At the time the Foster Family takes possession of the dog, MWABR has already provided B at a minimum B the following vaccinations and tests at the intervals required by law and/or advised by their veterinarian: rabies, distemper/parvo combination, bordetella, and a heartworm test followed by a regular course of preventative.

5. The Foster Family agrees that the dog will reside in his/her home and will be kept as a household pet.

6. The Foster Family agrees to leave on the collar and identification tag provided for the dog by MWABR to wear at all times when allowed outdoors, and if provided with a MWABR identification tag, that will also remain affixed to the collar.

7. MWABR makes no warranties or representations regarding the dog=s health or temperament. It is agreed and understood by the Foster Family that while every effort is made to provide an accurate history and assessment of a dog, MWABR does not warrant any dog regarding medical status, behavior, or disposition. It is further agreed that environmental changes may effect and change the temperament of the dog and that MWABR has no liability or responsibility of any nature regarding defects with the dog, or injuries or damage to any person or property which may be caused by the dog. The Foster Family agrees to indemnify and hold harmless MWABR, its members and representatives against any and all claims, known or unknown, now or hereafter arising in connection with this dog.

8. The Foster Family consents to the examination of this dog by MWABR at any time with 24 hours notice, and acknowledges that MWABR has the right to reclaim the dog at any time.

9. The Foster Family agrees that if for any reason, he/she cannot keep this dog, he/she shall return it to MWABR. The dog shall not be given away, sold, exchanged or adopted without prior written consent of MWABR, and all completed paperwork for a legal adoption. The Foster Family understands that any friend or family member who wishes to take ownership of this dog will be required to apply to MWABR for the right to adopt and/or foster it.

10. If for any reason this dog has not completed its medical treatments (i.e. heartworm treatment, hookworm treatment, spay, neuter, etc.) prior to the execution of this contract, he/she agrees to work with MWABR to attend all appointments and follow-up visits that need to be made in order to have the dog healthy and ready for adoption. The Foster Family acknowledges that until this has been accomplished, MWABR has the right to and will reclaim the dog if the appointments are not made.

11. It is agreed and understood by the Foster Family and MWABR that this written agreement sets forth all

promises, agreements, conditions, and understanding between them, oral or written, and that both parties have fully read and understood all of this agreement.

12. The Foster Family agrees to pay MWABR for any and all expenses, including court costs and reasonable attorney=s fees, in enforcing the terms and provisions of this contract. Payment of these damages shall not excuse the Foster Family from returning the dog to MWABR.

I attest that the terms and conditions of this *Foster Contract* have been read and understood, and I agree to abide by them.
